

Privacy Policy

As a professional union, La Chambre Belge des Experts en Oeuvres d'Art / Belgische Kamer van Deskundigen in Kunstwerken (hereinafter: "The Chamber") is responsible for processing several data, including some personal data.

The personal data we process may concern you as a Member, former Member, Candidate Member or Third Party.

We are bound to inform you in your capacity as a **person concerned** whose personal data we process, about the following.

1. Personal data controller

The personal data controller is La Chambre Belge des Experts en Oeuvres d'Art.

2. Why do we process personal data?

The Chamber processes personal data with a view to coordinating the professional union. This personal data processing involves data on the Members themselves, former Members, Candidates or Third Parties contacting us.

In the absence of communication and processing of this data, we are not able to properly carry out our mission to coordinate the professional union and to involve you in it.

3. What and whose personal data?

For the purposes stated in section 2, The Chamber is authorised to process personal data such as: first name, surname, gender, e-mail address, telephone number, ID/profile photograph, postal address, statutes of your personal company, VAT number, trade register, national ID number, CVs, academic records, reference letters, former expertises, criminal records, ...

The Chamber, processes personal data which the concerned persons provide themselves.

Personal data may also come from public sources such as Central Companies Databases, the Belgian Gazette and its annexes, the National Bank of Belgium, ...

No data is processed unless necessary for the purposes as stated in section 2.

Personal data is not shared with other Data Controllers in third countries, except with the CEDEA (Confédération Européenne Des Experts d'Art).

Personal data of Members and Directors and, more generally, everyone involved in The Chamber, may be published on its website.

4. Who do we disclose data to?

In accordance with the above, and except when it is required to share personal data with organisations or entities involved for the purposes above (such as public bodies and CEDEA), The Chamber will not disclose personal data collected in this context, and will not sell, lend, or exchange them with any organisation or entity unless it has informed you first and you have given your express consent.

The Chamber uses third party IT service providers and uses a webmail.

The Chamber may take all necessary measures to manage the website and IT systems effectively.

The Chamber may disclose personal data when required so by any lawful authority or of on its own initiative if it considers, in good faith, that disclosing such data is required to comply with laws or regulations or to defend and/or protect rights or belongings of the association, its partners, its website and/or yourself.

5. Security measures

The Chamber implements security and organisational procedures to prevent any unauthorised access to personal data collected as stated, concerning both data collection and storage.

These procedures also apply to all subcontractors and partners of The Chamber.

6. Retention periods

6.1. Members, former Members and Candidates

The Members', former Members' and Candidates' data may be kept for life, including for filing purposes.

6.2. Third Parties contacting The Chamber

The Third Parties' data is kept only for as long as the Board might be informed.

6.3. Other personal data

Personal data on anyone else is kept only for as long as the applicable law, such as accounting, tax and social law, requests.

6.4. Once these periods end, personal data is deleted unless it has to be kept for longer under other legislation in force.

7. Access rights, correction rights, right to be forgotten, data portability, objections, non-profiling and reporting security failures
